RULES AND REGULATIONS

1. All entrants shall be confined to fishing from Ewa Beach Park, Puuloa Rifle Range Fenceline to Hau Bush, Barber's Point Fenceline. **SHORELINE ONLY**
2. Use of kites, boats, or any type of flotation device (trash bags, plastic bottles, balloons, etc.), swimming, surfboarding, or kayaking the bait, and/or lead line out is prohibited.
3. Entrant must cast his or her own pole out.
4. There is a four pole limit.
5. All qualifying fish must be hooked and landed after the official start time. **(6:00 PM FRIDAY JUNE 17, 2011)**
6. At the time of the strike, the fish must be hooked, fought and brought to gaff by the entrant only. Partner may assist only in removing the bell and safety rope, and landing the fish.
7. Hang bait method is allowed only if the leader line is connected directly to the reel and bait is hung from the tip of the pole.
8. Fish that appears to have been frozen, spoiled, and/or with foul odor will be disqualified.
9. Fish that has been mutilated and/or bitten by a shark will be disqualified.
10. A fish that has been entangled with another pole line and brought up on both lines will be disqualified.
11. Manually projected harpoon gaffs are legal for the purpose of landing a hooked fish.
12. Angler must be present and submit his or her own fish at the Weigh-In to qualify.
13. This tournament is based upon but not limited to the **RULES AND REGULATIONS** of the **EWA BEACH FENCELINE TO FENCELINE SHORELINE FISHING TOURNAMENT, 2011**. Anyone found to have violated these **RULES AND REGULATIONS** will be disqualified from this tournament and tournaments thereafter. All monetary awards will be forfeited.
14. **IMMEDIATELY AFTER LANDING FISH, YOU MUST CALL DANNY AT 292-2484. HE WILL COME TO YOUR LOCATION TO VERIFY FISH. YOU MUST LEAVE HOOK AND ONE FOOT OF LINE OR LEADER IN MOUTH OF FISH. ANY FISH NOT VERIFIED BY DANNY WITHIN ONE HOUR OF LANDING FISH WILL BE DISQUALIFIED.**
15. In case of natural disaster, tournament is cancelled upon activation of warning sirens. **Tournament will be made up at a later date.**
